### Corporate Membership Offering

- One (1) year commitment and a ninety (90) day written termination notice required

**The Basic Corporate Membership includes: three (3) Family Single Golf type Memberships** – With unlimited golf for the designated golfer from each family. All other family members are viewed as Social Members with full access to all Clubhouse programming and dining options plus all Aquatics amenities. These family Members may golf up to four (4) times per calendar year by paying normal greens and cart fees.

- One (1) Primary Corporate Membership holder
- Two (2) secondary Corporate Membership holders as designated by Primary Member

#### One Primary Membership # Issued to Account

- One statement - paid through company
  - 'Auto drafted' monthly.
- Statement will be subdivided by user for your convenience

#### One \$3,500 Initiation Fee for Corporate Membership \*\*\*Paid up front, one time only\*\*\*

- Attached to primary Membership holder with voting privileges
- Secondary Membership holders covered by Initiation Fee of Primary Holder, without voting privileges

#### \$1,000/year Membership Fee - for each additional Family Single Golf Membership beyond Primary Member

- Paid up front
- then ANNUALLY upon anniversary
- Membership holder names can be changed by Primary Member as needed.

#### Membership Dues: \$500/month

- Total for all three Memberships holders, combined.

#### Membership Food Minimum

- \$150/month for all three (3) Membership holders combined.
- Irrespective of which Membership holder (or combination) actually spends it.

#### Additional Benefits

- Unlimited used of Clubhouse
- Banquet facilities
- Meeting rooms
- Unlimited use of Aquatics facilities
- Use of golf course for 'corporate' sponsored events. --- Work with Dan in the pro shop to set up.

#### SUMMARY

- \$5,500 upfront (Initiation Fee and Additional Member Fee) + \$650/month (Dues and Food Minimum).
- Full use of facilities (Golf for designated golfer, Aquatics and Clubhouse activities for everyone).
- One convenient Membership number with sub-divided classification for ease of bill determination.
- Auto Draft on subsequent purchases.
- One year commitment and 90 day written termination notice required.
